

Red Blood and White Snow: Murder in the North

A Selected Bibliography of Secondary Sources on Scandinavian Crime Fiction by Thomas Przybilka (Bonn, Germany)

This selected (and partly annotated) bibliography of secondary sources on Scandinavian crime fiction is divided into two parts:

“General” offers a view on books and articles dealing with crime fiction in general in the different Scandinavian countries or Scandinavia itself.

The second part, “Authors” assembles sources that deal with some of the most well-known Scandanavian crime writers or describes articles that are dedicated for the most part to the that writer. To give a short overview of contemporary Scandinavian crime writers, I chose the following important representatives by following the very good German analysis **Fjorde, Elche, Mörder**.

Der skandinavische Kriminalroman edited by Jost Hindermann: Dan Turèll (Denmark); Arne Dahl, Henning Mankell, Liza Marklund, Håkan Nesser (all Sweden); Leena Letholainen (Finland); Arnaldur Indridason (Iceland) and Maj Sjöwall & Per Wahlöö (Sweden). They are representatives of the “modern classic” Scandinavian crime fiction who have set benchmarks in the genre for Scandinavia as well for all of (Western) Europe. In their series built up around Inspector Martin Beck, Maj Sjöwall and Per Wahlöö in particular established the so-called social criticism crime novel, which has influenced all of western crime writers.

Annotations in square brackets quote the country in which the book or article was published. Most of the sources mentioned in this bibliography can be found in the collection of BoKAS — Bonner Krimi Archiv [Sekundärliteratur]. Web-addresses are not quoted, because it has been my experience that these sites often change htmls or vanish from the Web. Instead I have merely noted that I found the source online. If someone is interested in these sites, she or he will find it very easy to locate the site by “googling.”

You will note that the names of the authors

mentioned in this short selected bibliography recur. The reason is that there are only a few people in Europe (authors of reference books, of bibliographies or critics) who work seriously in the field of crime and mystery literature.

Last but not least, I like to thank my colleagues and friends, who have drawn my attention to works which I might otherwise have forgotten to mention: Keijo Kettunen (Finland); Bjarne Nielsen (Denmark); Johan Wopenka (Sweden); and my friend and translator: Dr. Mary W. Tannert (USA/Germany).
